一般條款及細則

優惠條款及細則

電子外幣兌換專享「獎賞錢」獎賞（「優惠」）

1. **推廣期：**有效期為2018年7月23日至2018年9月30日，包括首尾兩天。
2. **誰可享用此優惠：**本優惠適用於所有本行個人綜合理財客戶（滙豐卓越理財、滙豐運籌理財或個人綜合理財戶口）並持有合資格信用卡（見以下之定義）（「合資格客戶」）。若屬聯名戶口，則只有基本戶口持有人可獲贈此優惠。
3. **獎賞：**合資格客戶於推廣期內合資格交易累積每滿港幣20,000元可享\$50「獎賞錢」（「獎賞錢」），最高可享\$500「獎賞錢」。

有關「獎賞錢」會於2018年12月31日或之前自動誌入「合資格信用卡」戶口內。

「獎賞錢」不可兌換現金及不得轉讓。

如客戶於存入「獎賞錢」前終止他/她的合資格賬戶(即使已完成合資格交易)將不獲享本優惠。

General terms and conditions

1. The Hongkong and Shanghai Banking Corporation Limited, Hong Kong (and its successors and assigns) (the “**Bank**” or “**HSBC**”) may withdraw or terminate the Offer (as described below), and to change the applicable terms and conditions at any time. The latest details of the Offer and the revised terms and conditions will be made available on our website and/or communicated to customers by other means as soon as practicable.
2. No person other than the Eligible Customer (as defined below) and the Bank will have any right under the Contracts (Rights of Third Parties) Ordinance to enforce or enjoy the benefit of any of the provisions of these terms and conditions.
3. In the event of any dispute arising out of this Offer, the decision of the Bank shall be final.
4. The Offer is provided subject to the prevailing regulatory requirements.
5. These terms and conditions are governed by and construed in accordance with the laws of the Hong Kong Special Administrative Region.
6. Where there is any discrepancy between the Chinese and English versions of these terms and conditions, the English version shall apply.

Offer terms and conditions**RewardCash offer for digital currency exchange transaction (the “Offer”)**

1. **Offer Period:** 23 July 2018 to 30 September 2018 (both dates inclusive).
2. **Who can enjoy the Offer:** The Offer is only applicable to customers with HSBC personal integrated account (HSBC Premier, HSBC Advance or Personal Integrated Account) and maintain an Eligible Credit Card (as defined below) (the “**Eligible Customer**”). For joint accounts, only the principal accountholder is entitled to the Offer.
3. **Reward:** An Eligible Customer will be entitled to \$50 RewardCash (the “**RewardCash**”) for every HK\$20,000 of accumulated Eligible Transaction (as defined below) executed within the Offer Period, up to \$500 RewardCash. The RewardCash will be credited to the Eligible Credit Card maintained by the Eligible Customer on or before 31 December, 2018.
The RewardCash cannot be converted into cash and is not transferable.
Unless otherwise specified, the terms and conditions of RewardCash Programme also apply.
4. **Eligible Credit Card:** In order to enjoy the Offer, the Eligible Customers must maintain a Hong Kong Dollar personal primary credit card issued by HSBC in Hong Kong which is valid and in good standing by the time when the RewardCash is credited.

5. **Eligible Transaction:** Any currency exchange transaction which have been successfully executed by using the Eligible Customer's integrated account (HSBC Premier, HSBC Advance or Personal Integrated Account) via HSBC Internet Banking or HSBC Mobile Banking.
Currency exchange transactions conducted via FX Order Watch Trading Services, HSBC's Global Transfer service, notes exchange, cash deposit, notes withdrawal, outward/inward remittance, or exchange transactions made with any HSBC's offices or branches outside Hong Kong are not qualify for the Offer.
For customers who terminates his/her integrated account (through which the Eligible Transaction is conducted) before the RewardCash is credited will not be eligible for the Offer.
