

## HSBC X Ztore Offer Terms and Conditions

- The promotional period of this programme (the "Offer") is from 15 December 2018 to 31 December 2018 (both dates inclusive) (the "Promotional Period"). This Offer is offered by The Hongkong and Shanghai Banking Corporation Limited in the Hong Kong Special Administrative Region ("Hong Kong") (and its successors and assigns) ("HSBC" or the "Bank") and Ztore.
- Subject to the terms and conditions below, a HSBC HK Mobile Banking app user (the "Eligible User") will be entitled to receive up to HKD40 Ztore's cash equivalent consumable loyalty points ("Z-Dollar") for their order upon performing the following actions:

- 6. This is not applicable to purchase using mobile browsers as payment via FPS is not available through mobile browsers during the Promotional Period.
