

## HSBC HK App 2020 "Live while you bank" Lucky Draw Offer Promotional Terms and Conditions:

- 1. The promotional period of the HSBC HK App 2020 "Live while you bank" Lucky Draw (the "Lucky Draw") is from 17 August 2020 to 30 November 2020 (both dates inclusive) (the "Promotional Period"). The Lucky Draw is offered by The Hongkong and Shanghai Banking Corporation Limited in the Hong Kong Special Administrative Region ("Hong Kong") (and its successors and assigns) ("HSBC" or the "Bank").
- 2. The Lucky Draw is exclusive to customers who are the sole or (if a joint account) principal account holders of any HSBC account (the "Applicable Account") and fulfil all the following requirements (each, an "Eligible Customer" and, collectively, the "Eligible Customers"):
  - a. Be aged 18 or above on 16 August 2020;
  - b. Have a valid Hong Kong local correspondence address and a valid email address under the Bank's record; and
  - c. Maintain the Applicable Account, Personal Internet Banking service and HSBC HK App at the time of offer fulfilment.

Any person who does not fulfil the above criteria for the entirety of the Promotional Period will automatically be disqualified from participating in the Lucky Draw. Any person who acts in breach of applicable laws and regulations or who has an actual or potential conflict of interest will also be disqualified from participating in the Lucky Draw. No person can participate in the Lucky Draw if he / she has been involved in setting up or running this Lucky Draw.

- 3. During the Promotional Period, Eligible Customers can get one (1) basic Lucky Draw entry daily during the promotional period by completing both of the following actions as listed below:
  - a. logging on to the HSBC HK App on a day; and

- Make transfers
- Perform currency exchange
- Apply for Credit Card
- Apply for TravelSurance
- View eStatement and eAdvice
- Make HSBC Global Transfer
- Perform transaction in FlexInvest

If the designated instruction / transaction as listed under Clause 3(b) that an Eligible customer performs fulfils the additional criterion / criteria ("Additional Criteria") as listed below, he / she will be entitled to (an) extra Lucky Draw entry multiplier(s) with his/her basic Lucky Draw entry according to each of the criterion respectively:

Additional Criteria	Lucky Draw entry multiplier
Performed when the Eligible Customer logs on to the HSBC HK App for the first time ever during the Promotional Period	10x
Under "Pay & Transfer" as in the HSBC HK App	5x
Performed on Saturday, Sunday and public holidays during the Promotional Period	2x

An Eligible Customer is entitled to have a maximum of one hundred (1x2x5x10=100) Lucky Draw entry on each day.

The promotional period is divided into three (3) phases ("Promotional Phases") as listed below:

- 4. An Eligible Customer can only get a maximum of one (1) basic Lucky Draw entry on each day during the Promotional Period. Only the first designated instruction done within the day would be counted for getting a basic Lucky Draw entry. No additional basic Lucky Draw entries would be gained from logons and designated transaction or instructions thereafter within the same day.
- 5. An Eligible Customer who fulfils the criteria as listed under Clause 3 during Promotional Phase 1 will be entitled to enter the Lucky Draw automatically with no registration needed to win a set of thirty (30) HKD200 vouchers from Deliveroo worth of HKD6,000 (the "Phase 1 Prize"/"Prize").

Hong Kong local correspondence address according to Bank's record at the time of fulfillment:

Phase 1	On or before 30 November 2020
Phase 2	On or before 31 December 2020
Phase 3	On or before 31 January 2021

- 10. Each Winner who receives the Redemption Letter is required to redeem the Prize according to the instructions stated in the Redemption Letter, otherwise the Prize will be deemed to be forfeited.
- 11. The Bank reserves the right to replace the Prize with any alternative gift without prior notice.

- 13. Use of the Prize (or any alternative gift) is subject to the suppliers' terms and conditions applicable thereto.
